18/20/8 To consider planning application 18/3362M, Erection of 3 no. dwellings and associated car parking, infrastructure and landscaping following the demolition of existing building. Depot rear of 64 to 72 Delamere Road, Handforth.

The Parish council recommend refusal of this application on the following grounds: The Parish council consider the building density too great at this location, this will lead to a loss of privacy and outlook for some neighbouring properties. The Parish council considers that the parking provision provided in the application does not meet the minimum required standard of two car parking spaces per household. Finally the Parish council requests that the case officer takes great care in noting the holding objection put forward by Network Rail, and whilst the Parish council are not experts in these matters the case officer should confer with Network Rail to ensure that the application will not be of detriment to the railway at this location.
