

1. An election is to be held for **ONE** Town Councillor for **Handforth Town Council – South Ward**
2. Nomination papers must be hand-delivered to the Returning Officer, Elections Office, Macclesfield Town Hall, Market Place, Macclesfield, Cheshire, SK10 1EA, **on any day after the date of this notice, (excluding weekends and bank holidays),** between the hours of 10.00am and 4.00pm, **BUT NOT LATER THAN 4.00pm on Friday 26 November 2021. Please telephone 01270 685922 to make an appointment to deliver your nomination paper.**
3. Nomination papers may be obtained from the Returning Officer, Elections Office, Macclesfield Town Hall, Market Place, Macclesfield, Cheshire, SK10 1EA, between the dates stated in paragraph 2 above. Written requests for nomination papers must be sent to the Elections Office, Macclesfield Town Hall, c/o Municipal Buildings, Earle Street, Crewe, Cheshire, CW1 2BJ.
4. If the election is contested, the poll will take place on **Thursday 23 December 2021** between the hours of 7.00am and 10.00pm.
5. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on **Tuesday 7 December 2021**. Applications can be made online: <https://www.gov.uk/register-to-vote>
6. Electors and their proxies should take note that:  
Any changes to, or cancellations of, existing postal or proxy vote records, and new applications to be treated as postal voters, must reach the Electoral Registration Officer, either by hand at the Elections Office, Macclesfield Town Hall, Market Place, Macclesfield, Cheshire, SK10 1EA, or by post at the Elections Office, Macclesfield Town Hall, c/o Municipal Buildings, Earle Street, Crewe, Cheshire, CW1 2BJ by **no later than 5.00pm on Wednesday 8 December 2021** if they are to be effective for this election. You must allow sufficient time for posted applications to be received in the Elections Office by the deadline.

New applications for proxy voting arrangements must reach the Electoral Registration Officer, either by hand at the Elections Office, Macclesfield Town Hall, Market Place, Macclesfield, Cheshire, SK10 1EA, or by post at the Elections Office, Macclesfield Town Hall, c/o Municipal Buildings, Earle Street, Crewe, Cheshire, CW1 2BJ by **no later than 5.00pm on Wednesday 15 December 2021**, if they are to be effective for this election. You must allow sufficient time for posted applications to be received in the Elections Office by the deadline.

Applications to vote by emergency proxy at this election must reach the Electoral Registration Officer, either by hand at the Elections Office, Macclesfield Town Hall, Market Place, Macclesfield, Cheshire, SK10 1EA, or by post at the Elections Office, Macclesfield Town Hall, c/o Municipal Buildings, Earle Street, Crewe, Cheshire, CW1 2BJ by **5.00pm on Thursday 23 December 2021** if they are to be effective for this election. You must allow sufficient time for posted applications to be received in the Elections Office by the deadline.
